Fiscal Note

This agreement will provide assistance to Metro Transit for providing transit information services, promotion efforts and operations in the amount of \$19,300. It will also provide \$5,000 in assistance to the Madison Area Transportation Planning Board for coordination of specialized transportation services. The funds are included in the respective 2012 Operating Budgets (Planning Division/MPO and Metro Transit).

WHEREAS, the 2012 Dane County budget includes various technical assistance and coordination efforts regarding the provision of specialized transportation services; and

WHEREAS, this budget includes funding support for Metro Transit in the amount of \$19,300 for transit information service, promotion efforts and operations for the calendar year 2012, and \$5,000 to the Madison Area Transportation Planning Board to support the 2012 Dane County coordination activities; and

NOW, THEREFORE BE IT RESOLVED that the Mayor and the City Clerk are authorized to enter into an agreement with Dane county for providing services to Metro Transit and the Madison Area Transportation Planning Board for the 2012 calendar year for a total of \$24,300.
