Park Street, 906-918 Midland Street and 1101-1109 Fish Hatchery Road, City of Madison, Dane County, Wisconsin has been duly filed for approval by the Plan Commission, its Secretary or his/her designee, as provided for in Section 16.23(5)(g) of Madison General Ordinances; and

WHEREAS a one-lot Certified Survey Map of property owned by Charles A. Ghidorzi, Crab Tree Ridge, LLC located at 1102 S. Park Street, 906-918 Midland Street and 1101-1109 Fish Hatchery Road, City of Madison, Dane County, Wisconsin has been duly filed for approval by the Plan Commission, its Secretary or his/her designee, as provided for in Section 16.23(5)(g) of Madison General Ordinances; and

BE IT FURTHER RESOLVED that the Planning Division is authorized to reflect the recorded Certified Survey Map in the Comprehensive Plan and any applicable neighborhood plans.
