Amending the 2012 Public Health Operating Budget to allow for the carryforward of two grants from 2011. **Body**

WHEREAS two grants from the Susan G. Komen Foundation for the Cure to Public Health-Madison and Dane County Well Woman program are for the term April 1, 2011 through March 31, 2012;

WHEREAS \$42,376 remains in the Treatment Access Fund to be spent on breast screening and support services and \$16,418 remains in the Treatment Access Fund initiative for African-American women;

NOW THEREFORE BE IT RESOLVED that the 2012 Operating Budget for Public Health-Madison and Dane County is amended to reflect the carryforward of these grants, using the accounting strings and amounts in the attachment to this resolution.
