#### Fiscal Note

The projected cost for the remainder of 2012 is approximately \$2,400 (or \$3,300 including fringe benefits) and was not anticipated in the Police Department's Operating Budget. If sufficient funding is not available through management of salary savings, funding for this reclassification will be included in the Police Department's year -end appropriation request. The projected estimated annualized cost is \$6,350 (or \$8,660 including fringe benefits).
