#### Title

Authorizing the Greater State Street Business Association (GSSBA), as sponsor of CARS ON STATE, EXCLUSIVE RIGHTS to select vendors, salespersons, vending sites and performers for the duration of CARS ON STATE, Saturday, June 2, 2012 within the perimeter of the area involved in the event.

#### Body

WHEREAS, Section 9.13(6(k)4. of the Madison General Ordinances authorizes the Common Council to allow the sponsor of a special event to select alternate vendors, salespersons, and vending sites within the perimeter and for the duration of a special event; and

WHEREAS, Section 9.13(6)(k)4. further requires that this authority only be granted upon a separate resolution after some or all vending licenses have already been invalidated within the perimeter of a special event; and

WHEREAS, the Common Council has already approved the invalidation of some or all vending licenses within

the perimeter of the CARS ON STATE in Resolution

No. <u>25937</u>; and

WHEREAS, the GSSBA has complied with the procedures set forth in Sec. 9.13(6)(k)4. to provide written notice of proposed rules, regulations, fees, and areas affected as well as notice of this hearing to all vendors within the perimeter of the event; and

WHEREAS, the event sponsor shall obtain a Special Event Vending License for all selected vendors, as required by sec. 9.13(2) and(3); and

WHEREAS, the event sponsor will limit vendor participation to lessees and owners of businesses in the Mall/Concourse district and the "greater State Street business area" as defined by the event sponsor;

NOW, THEREFORE, BE IT RESOLVED, that the GSSBA is hereby authorized to select vendors, salespersons and vending sites within its perimeter for the duration of the special event described in Resolution No. 25937.
