PREAMBLE:

The City is proposing to reconstruct County Trunk Highway M (CTH M) from Prairie Hill Road to Cross Country Road in 2015/2016. The consultant's services will include traffic modeling of current and future traffic volumes, the completion of preliminary plans and the Environmental Assessment report and Final Plans & Specifications. The project also includes the reconstruction of CTH M/Midtown Road and CTH M/CTH PD intersections. The consultant's services include intersection analysis to determine the possibility for Traffic Signals or a Roundabout at these intersections.

The City Engineer recommends that additional design services be undertaken by MSA Professional Services. They are:

- 1. Additional design alternative analysis for CTH M & CTH PD intersection
- Additional design services for Mid Town Road & CTH PD Ped/Bike Underpass
