**Fiscal Note**

Costs for the remainder of 2012 are estimated at \$1,368, or \$1,889 including benefits. These amounts will be accommodated by the management of Streets Division salary savings. Annualized costs are estimated at \$7,644, or \$10,556 including benefits, based upon a comparison of maximums. These costs will be included in future year Streets Division operating budget requests.
