### Fiscal Note

This project is included in the 2013 Executive Capital Budget. The actual construction, estimated to cost \$2,985,786.50, will not take place until 2013. Some of the estimated \$175,000 easement acquisition may occur in 2012 but there is sufficient budget authority to cover those costs until the 2013 Capital Budget is adopted.

City Engineering and Real Estate are authorized to proceed to create the needed Relocation Order subject to future council approval of that work.
