### Fiscal Note

The Employment Agreement establishes an annual salary of \$130,098 beginning August 4, 2013. The Water Utility's 2013 Operating Budget includes \$124,620 for the Water Utility General Manager position; however, the additional funds necessary are available from the management of salary savings. Annual salary adjustments may be made during the term of the agreement at the Mayor's discretion, subject to Common Council approval.

WHEREAS, Mayor Soglin has appointed Thomas O. Heikkinen to the position of Water Utility General Manager and has recommended to the Common Council that his appointment be confirmed; and
