Fiscal Note

Recreation of the Fleet Parts Manager (18-07) to a Fleet Operations Manager (18-12) can be expected to cost an additional \$16,394, or \$22,329 including benefits, on an annualized basis. Recreation of the Fleet Services Maintenance Supervisor (18-08) to a Fleet Program Manager (18-12) can be expected to cost an additional \$13,517, or \$18,410 including benefits, on an annualized basis. Deletion of the existing Fleet Service Program Supervisor (18-12) is expected to save \$78,730, or \$107,230 including benefits, on an annualized basis. Annual net savings of \$66,491 are therefore anticipated. No appropriation is required.

Resolution that the 1.0 FTE position of Fleet Parts Manager, #1159 (occupied by R. Janowski), in CG18-07, shall be deleted and recreated as a Fleet Operations Manager, CG18-12. The 1.0 FTE position of Fleet Services Maintenance Supervisor, #3274 (occupied by A. Meyer), in CG18-08, shall be deleted and recreated as a Fleet Program Manager, CG18-12 in the permanent salary detail of the Fleet Services Division budget. The respective incumbents of positions #1159 and #3274 shall be reallocated to the new positions. The vacant Fleet Services Program Supervisor (CG 18, R12), position #1170, will be deleted to fund the new positions, thereof.
