Title

Approval to accept Homeland Security Metropolitan Medical Response System grant (2011-HSW-20 10312) awarded by the Wisconsin Department of Military Affairs Homeland Security program for \$267,609.

Body

The City of Madison Fire Department has received notification from the State of Wisconsin Department of Military Affairs as to the award of a grant for the Metropolitan Medical Response System (MMRS) in the amount of \$267,609. The grant covers the metropolitan area which includes Dane County. The focus areas for this program are interoperable communications, medical supplies, training, exercises, mass casualty response, alternate care facilities and patient care.
