#### Title

Authorizing the execution of an Underground Electric Line Easement to Madison Gas and Electric Company across a portion of the City Water Utility Reservoir #106 property, located at 126 Glenway Street.

#### **Body**

WHEREAS, the City Water Utility is reconstructing the water reservoir #106 facility, located at 126 Glenway Street; and

WHEREAS, Madison Gas and Electric Company ("MG&E") will be upgrading the electric service to the Water Utility facility and undergrounding the existing overhead electric line located along Glenway Street, and therefore have requested an underground electric line easement, across a portion of the Water Utility property, for their new underground electric line facilities; and

WHEREAS, City of Madison Water Utility and Office of Real Estate Services staff have reviewed and approve of the granting of said easement.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and the City Clerk are hereby authorized to execute an Underground Electric Line Easement to Madison Gas and Electric Company across a portion of the Water Utility property, located at 126 Glenway Street, legally described as follows:

Two strips of land, ten (10) feet in width, located in part of Southwest ¼ of Section of Section 21, Town 7 North, Range 9 East, City of Madison, Dane County, Wisconsin, of said strips being more particularly described as follows:

The right of way shall be located approximately as set forth in the drawing attached hereto as Exhibit A and dated October 7, 2013.
