Body

PREAMBLE

The City of Madison has scheduled the resurfacing of W. Badger Road from Park Street to the west end and also the West Beltline Highway Frontage Road from W. Damon Road to Whalen Road. A portion of each right-of-way lies within the Town of Madison. The City of Madison shall resurface the roadways with the 2014

Resurfacing Contract, and each municipality shall be responsible for the cost to resurface their share. Additionally, the City shall rehabilitate a Town of Madison Sanitary Sewer that is jointly and equally used by both the Town and the City.

NOW THEREFORE BE IT RESOLVED that the Mayor and City Clerk are hereby authorized to enter into agreements with the Town of Madison for cost sharing the resurfacing of West Badger Road and the West Beltline Highway Frontage Road and for Sanitary Lining on West Badger Road.
