## **Fiscal Note**

The provisions in these labor agreements with a fiscal effect include an increase in night and Saturday premium shift differentials from 58 cents per hour to 75 cents per hour and a decrease in the Sunday shift premium from \$1.78 per hour to \$1 per hour. Based on 2013 hours, the combination of these changes is expected to reduce costs by approximately \$2,200.
