Fiscal Note

A provision in these agreements allows the affected employees to carryover up to 6 days unused sick leave from one year to the next. This is expected to increase by \$17,000, the City's liability for compensated absences. Beginning in 2016, approximately \$9,000 will be paid for sick days carried over from the previous year that exceed the 6 day maximum.

Other provisions in these agreements have minimal fiscal effects.
