Whereas, Madison is fortunate to have a safe, reliable water system; and

Whereas, worldwide over one billion people have no access to clean and safe drinking water; and

Whereas, Wisconsin Water for the World (<a href="www.wisconsinwaterfortheworld.org">www.wisconsinwaterfortheworld.org</a>) brings together engineers, teachers and water professionals from around the state to build sustainable drinking water systems in remote Guatemalan villages; and

Whereas, Wisconsin Water for the World volunteers donate their time, expertise, and travel expenses, so all contributions to the charity go toward the actual building of drinking water systems, operations training, sanitation, and health and hygiene education for the communities served; and

Whereas, Madison Water Utility would like to bring awareness and raise money for Wisconsin Water for the World as part of the Open House by having a silent auction and coffee & chocolate tasting that features fair trade Guatemalan coffees, chocolates, and other goods donated by local businesses;
