### **Fiscal Note**

It is anticipated that the Equity Core Team, which is an interdepartmental team with representatives from various City agencies, will develop a pilot program and plan, including implementation strategies and any associated costs. The team will develop a budget to implement a pilot, but any additional funding or significant reallocations of existing funding are subject to further Council approval. No appropration is required at this time as the initial efforts will be supported with existing staff resources.

## **Body**

WHEREAS, the Draft "Fair Housing Equity Assessment" conducted as part of the Capital Area Regional Planning Commission Sustainable Communities Initiative demonstrated disparate levels of access to opportunity in Madison; and,

WHEREAS, inequitable access to opportunity hampers individual well-being and community and economic stability; and,

WHEREAS, the Draft "Fair Housing Equity Assessment" considered barriers related to transportation, income, language, employment, education, segregation, housing costs and age composition in its analysis; and,

WHEREAS, some Madison neighborhoods face higher barriers to opportunity than average; and,

WHEREAS, the Draft "Fair Housing Equity Assessment" offers a replicable framework to identify barriers to opportunity,

NOW THEREFORE BE IT RESOLVED that the Common Council directs the Equity Core Team to develop a pilot project, utilizing the Draft "Fair Housing Equity Assessment" framework to address factors limiting access to opportunity in those neighborhoods with concentrated barriers to opportunity; and,

BE IT FINALLY RESOLVED that the Common Council asks the Equity Core Team to incorporate best practices for community engagement and data management as part of this initiative.
