The City is proposing to reconstruct McKee Rd / County Trunk Highway PD (CTH PD) from Meriter Way to Maple Grove Road in 2017. The consultant's services will include traffic modeling of current and future traffic volumes, the completion of preliminary plans and the Environmental Assessment report and Final Plans & Specifications.

Pursuant to City Ordinances and Policies, the City Engineer advertised for consultant proposals, reviewed the submitted proposals, and recommends the design engineering contract be awarded to K.L. Engineering.

The City of Madison, City of Verona and Dane County are all participating in the design and shall cost share the design engineering contract.
