Authorizing the Mayor and City Clerk to execute agreements and the Finance Director to issue purchase orders to MG&E, Charter Communication, and US Signal for the undergrounding of overhead utilities along Cottage Grove Road and Dempsey Road.

### Body

Preamble:

Overhead electrical and communication lines run along Cottage Grove Road and Dempsey Road adjacent to Royster Corners. Funds are included in the 2014 and 2015 Engineering Major Streets Capital Budget for new street construction, street reconstruction and undergrounding of overhead utilities on Cottage Grove Road and Dempsey Road. MG&E, Charter Communication, and US Signal will underground their overhead facilities and remove poles along Cottage Grove Road and Dempsey Road. The work will be done in 2014/2015 prior to the reconstruction of Cottage Grove Road.

NOW THEREFORE BE IT RESOLVED, that the Common Council hereby authorizes the Mayor and City Clerk to execute agreements and the Finance Director to issue purchase orders to MG&E, Charter Communication, and US Signal for the undergrounding of overhead utilities along Cottage Grove Road and Dempsey Road
