Fiscal Note

The cost for the remainder of 2014 is approximately \$900 (or \$1,000 including benefits). The projected annualized cost based on the incumbent in the position is \$8,660 (or \$9,930 including benefits) and is budgeted in the 2015 Golf Executive Operating Budget as amended by the Board of Estimates.
