WHEREAS, Great Neighborhoods West, LLC has satisfactorily completed the installation of bituminous surface improvements by private contract in accordance with the City of Madison Standard Specifications for Public Works Construction for: Linden Park - Phase 3.

NOW, THEREFORE, BE IT RESOLVED

- 1. That the bituminous surface improvements on the following streets be and are hereby accepted:
 - Sundance Drive from Valley View Road to Ancient Oak Lane.
 - Silkwood Trail from the east line of Lot 64 to the east plat line.
 - Ancient Oak Drive from the east line of Lot 18 to the east plat line, including sidewalk on the north side of Outlot 4.
 - Snowberry Lane from Color Peak Road to Sundance Drive.
 - · Hollybush Lane from the east line of Lot 45 to Sundance Drive.
 - Color Peak Road from the north line of Lot 37 to Ancient Oak Lane.
