Body

Preamble

The parties, the City of Madison ("City") and Meyer Scherer & Rockcastle, Ltd. ("Architect" or "Contractor") entered into a contract for the purchase of professional architectural pre-design (programming and preliminary concept) services for the MMB on July 15, 2014 (RES-14-00545). The pre-design process is nearing completion. The contract amendment is to assess the conceptual cost and related impacts associated with minimal to advanced rehabilitation efforts at the MMB. The building improvement scenarios shall be based on previous assessments of the building systems and their current physical conditions. The outcome of this scenario planning will be summary documentation of each scenario including conceptual level budget and operational implications.
