Fiscal Note

In 2015, the estimated additional annual cost is \$3,200 for wage expense, plus \$640 for fringe benefits, or a total additional cost of \$3,840. The Mayor's Office will need to manage its budget to accommodate the additional expense in 2015, or a budget amendment may be needed later in the year. The full, annualized additional future expense at Step 5 is \$7,448 for wage expense, plus \$1,490 for fringe benefits, or a total additional cost of \$8,938 and will need to be included in future operating budgets, subject to Council approval.
