WHEREAS, CITY and COUNTY have determined that a portion of County Trunk Highway ("CTH") S, located in CITY, was reconstructed, which required contributions from CITY and COUNTY; and

WHEREAS, the Project will be financed by a combination of Federal, COUNTY and CITY funds; and

WHEREAS, funding is to be accomplished in accordance with county policies and past practices of cost sharing on similar CTH projects; and

WHEREAS, CITY and COUNTY wish to formalize the transfer of jurisdiction of that portion of CTH S (0.4 mile), within the City corporate limits from COUNTY to CITY; and
