### Title

Authorizing the Mayor and the City Clerk to execute an agreement with Strand Associates for design engineering services for E. Johnson St. (Baldwin St. to First St.).

### Body

#### PREAMBLE

The City is proposing to reconstruct E. Johnson St. from Baldwin St. to First St. in 2018. The consultant's services will include the completion of preliminary plans and the Environmental Assessment report and Final Plans & Specifications.

Pursuant to City Ordinances and Policies, the City Engineer advertised for consultant proposals, reviewed the submitted proposals, and recommends the design engineering contract be awarded to Strand Associates.

This will be a multi-year design project (2015-2017) and construction is scheduled for 2018. \$390,000 has been budgeted for the street design in 2015 and the remainder will be included in a future budget.

NOW THEREFORE BE IT RESOLVED that the Mayor and City Clerk are hereby authorized to execute and agreement with Strand Associates for design engineering services for E. Johnson St. (Baldwin St. to First St.).
