### Fiscal Note

Costs for the remainder of 2015 are estimated at \$1,770, or \$2,026 including benefits. Annualized costs are projected at \$2,202, or \$2,520 including benefits. Costs for the remainder of 2015 will be accommodated by the management of salary savings.

### Title
