Title

Authorizing the execution of an Underground Electric Line Easement to Madison Gas and Electric Company across a portion of the City Water Utility Well #31 property located at 4901 Tradewinds Parkway.

Body

WHEREAS, the City Water Utility is constructing a new water pump station and reservoir facility, ("Well #31"), located at 4901 Tradewinds Parkway; and

WHEREAS, Madison Gas and Electric Company ("MG&E") will be installing new underground electric service to serve the City Water Utility facility, and therefore have requested an underground electric line easement, across a portion of the City Water Utility Well #31 property; and

WHEREAS, City Water Utility and Office of Real Estate Services staff have reviewed and approve of the granting of said new underground electric easement.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and the City Clerk are hereby authorized to execute an Underground Electric Line Easement to MG&E across a portion of the City Water Utility Well #31 property, located at 4901 Tradewinds Parkway, legally described as follows:

A strip of land, ten (10) feet in width, located in Lot 9, Genesis Plat, lying in part of the NE 1/4 of Section 27,

T7N-R10E, City of Madison, Dane County, Wisconsin, the centerline of said strip being more particularly described as follows:

The right of way shall be located 5 feet on the right side and 5 feet on the left side of the centerline of the Grantee's facilities as constructed. The facilities will be located approximately as set forth in the drawing attached hereto as Exhibit A.
