Cardinal Glenn - Phase 8

NOW, THEREFORE, BE IT RESOLVED

- 1. That said sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) be and are hereby accepted.
- 2. That said sanitary sewer improvements are hereby assigned to the Madison Sewer Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Sewer Utility's "Utility Plant In Service".

That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A" \$16,612.20.

- 4. That the street improvements, **excluding the bituminous pavement**, on the following streets be and are hereby accepted:
 - Harvest Moon Lane from the west line of Lot 5 (existing street) to the east plat line.
 - Roman Mist Way from the north line of Lot 14 (existing street) to the south plat line.
 - · Stone Arbor Trail from Harvest Moon Lane to the south plat line

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 53B2359 \$ 34,626.46 for a useful life of 40 years.
