**Title**

Authorizing the execution of an Underground Fiber Optic Cable Line Easement to Dane County across a portion of Henry Vilas Zoo, located at 702 South Randall Avenue.

**Body**

WHEREAS, Dane County, in conjunction with the Henry Vilas Park Zoological Society, are upgrading the telecommunications service at the Henry Vilas Zoo (the "Zoo"), located on 702 South Randall Avenue; and

WHEREAS, Dane County has requested an underground fiber optic cable line easement, across a portion of the Zoo grounds, for the new telecommunication facilities; and

WHEREAS, City of Madison Parks Division and Office of Real Estate Services staff has reviewed and approve of the granting of said easement.

NOW, THEREFORE, BE IT RESOLVED that the Mayor and the City Clerk are hereby authorized to execute an Underground Fiber Optic Cable Line Easement to Dane County across a portion of the Henry Vilas Zoo property, legally described as follows:

Two strips of land, ten (10) feet in width, located in part of the Northeast Quarter of Section 27, Town 7 North, Range 9 East, City of Madison, Dane County, Wisconsin, the centerline of said strips being more particularly described as follows:

The right of way shall be located five (5) feet on the right side and five (5) feet on the left side of the centerline of the Dane County telecommunications facilities as constructed. The facilities will be located approximately as set forth in the drawing attached hereto as Exhibit A and dated April 30, 2015.
