#### **Fiscal Note**

The cost for 2016 is approximately \$8,300. There are three Information Technology (IT) reclass resolutions (40854, 40855, and 40856) introduced, of which this is one. The cost for 2016 of the three reclasses is approximately \$24,700. IT will need to monitor their salary savings throughout the year to fund these reclassifications.

#### **Title**

Recreate the 1.0 FTE position #841 of "IT Specialist 3" (CG18/10, currently occupied by R. Sjachrani) as "IT Specialist 4" (CG18/12, class code H248) in the Information Technology budget and reallocate the incumbent to the new position.

### **Body**

Resolution that the 1.0 FTE position #841 of "IT Specialist 3," currently occupied by R. Sjachrani, in Compensation Group 18, Range 10, in the permanent salary detail of the Information Technology budget, is deleted and recreated as "IT Specialist 4" (class code H248) in Compensation Group 18, Range 12, and that the incumbent is reallocated to the new position, thereof.
