DRAFTER'S ANALYSIS: This ordinance rezones property located at 722 Williamson Street from TSS to PD (GDP-SIP) (Planned Development (General Development Plan-Specific Implementation Plan) District and approves a General Development Plan and Specific Implementation Plan to allow renovating existing Olds Seed Building to include 7,200 square feet of commercial space and 45 apartments and construct new 96-unit apartment building with two levels of parking.
