#### **Fiscal Note**

Engineering's major capital project Rural to Urban Streets (MUNIS 10204) has authorized budget of \$4 million in the adopted 2016 capital budget to reconstruct streets with substandard pavement. The 2016 minor project for Turner Ave. (MUNIS 10904) is budgeted for the planned cost in this proposed resolution. The funding source for the majority of the project is from GO Borrowing.

The proposed resolution approves plan documents for the Turner Ave., Allis Ave., and Maher St. assessment district. The total project cost is \$2,756,110 with the budgeted amounts assigned as follows:

Engineering Major Streets - \$1,178,545 Stormwater - \$264,681 Sewer - \$722,884 Water - \$590,000

Total Cost \$2,756,110 City Share \$2,294,035 Asssessment \$462,075

## **Title**

Approving Plans, Specifications, And Schedule Of Assessments For Turner Avenue, Allis Avenue and Maher St Assessment District - 2016 and Authorizing the Mayor and City Clerk to enter into a Cost Sharing Agreement with the Town of Blooming Grove for the Allis Avenue Construction.

Body

The Board of Public Works and the City Engineer having made reports of all proceedings in relation to the improvement of Turner Avenue, Allis Avenue and Maher St Assessment District - 2016 pursuant to a resolution of the Common Council, RES-16-00108, ID No. 41420, adopted 2/2/16, which resolution was adopted thereto, and the provisions of the Madison General Ordinances and the Wisconsin Statutes in such case made and provided, and the Common Council being fully advised.

## BE IT RESOLVED:

- 1. That the City at large is justly chargeable with and shall pay the sum of \$2,294,035 of the entire cost of said improvement.
- 2. That for those eligible property owners requesting construction of a rain garden in the public right-of-way adjacent to their property shall execute the necessary waiver of special assessments on forms provided by the City Engineer;
- 3. That the sum assigned to each separate parcel, as indicated on the attached schedule of assessment, is hereby specially assessed upon each such parcel.
- 4. That the Common Council determines such special assessments to be reasonable.
- 5. That the work or improvement be carried out in accordance with the reports as finally approved.
- 6. That such work or improvement represents an exercise of the police power of the City of Madison.
- 7. That the plans & specifications and schedule of assessments in the Report of the Board of Public Works and the Report of the City Engineer for the above named improvement be and are hereby approved.
- 8. That the Board of Public Works be and is hereby authorized to advertise for and receive bids for the said improvements.
- 9. That the due date by which all such special assessments shall be paid in full is October 31<sup>st</sup> of the year in which it is billed, or,
- 10. That such special assessments shall be collected in eight (8) equal installments, with interest thereon at 3.0 percent per annum, except those special assessments paid in full on or before October 31<sup>st</sup> of that year.
- 11. That the Mayor and City Clerk are hereby authorized to execute an agreement with the Town of Blooming Grove for cost sharing for the construction of Allis Avenue.

## INSTALLMENT ASSESSMENT NOTICE

Notice is hereby given that a contract has been (or is about to be) let for Turner Avenue, Allis Avenue and Maher St Assessment District - 2016 and that the amount of the special assessment therefore has been determined as to each parcel of real estate affected thereby and a statement of the same is on file with the City Clerk; it is proposed to collect the same in eight (8) installments, as provided for by Section 66.0715 of the Wisconsin Statutes, with interest thereon at 3.0 percent per annum; that all assessments will be collected in installments as above provided except such assessments on property where the owner of the same has paid the assessment to the City Treasurer on or before the next succeeding November 1st.

#### NOTICE OF APPEAL RIGHTS

"Pursuant to Sec.4.09(14), Madison General Ordinances, as authorized by Sec. 66.0701(2), Wisconsin Statutes, any person against whose land a special assessment has been levied by this resolution has the right to appeal therefrom in the manner prescribed in Sec. 66.0703(12), Wisconsin Statutes, within forty (40) days of the day of the final determination of the Common Council, said date being the date of adoption of this resolution."
