### Fiscal Note

In the adopted 2016 capital budget, the Sewer Utility's major project for sewer reconstruction (MUNIS 10267) has \$1.1 million authorized for replacement of older sewers in coordination with the City's street reconstruction and pavement management projects. Funding for this project is provided by revenue bonds. The minor project for the Bassett/Bedford St. sewer rehab (MUNIS 11211) provides for the estimated cost in this proposed resolution.

The proposed resolution approves plan documents for the N. Bassett/Bedford St. project with an estimated cost of \$215,000 to be paid by the Sewer Utility.
