Fiscal Note

In the adopted 2016 capital budget, the Sewer Utility's major project for trenchless sewer rehabilitation (MUNIS 10450) authorizes \$2.3 million for repairs of failing sewers that meet criteria for rehabilitation. Funding for this project is provided by revenue bonds. The minor project for the CIPP Wet Lining Rehab (MUNIS 10800) has an available budget to provide for the estimated cost in this proposed resolution.

The proposed resolution approves plan documents for the CIPP Wet Lining Rehab with an estimated cost of \$499,855 to be paid from the Sewer Utility.
