Fiscal Note

In the adopted 2016 capital budget, Engineering Major Streets has budgeted \$3.77 million for the Royster Clark Development Phase 2 project (MUNIS 10250). Funding comes from a combination of TID 44 proceeds and State sources. There is sufficient budget authority for the cost of the proposed contract for all agencies involved. The proposed resolution approves the contract at an amount of \$4,400,780, which is split amongst agencies as follows:

Stormwater - \$501,950
Sewer - \$846,910
Water - \$732,860
