Fiscal Note

In the adopted 2016 capital budget, Engineering Major Streets has budgeted \$300,000 for the Neighborhood Traffic Management project (MUNIS 10546) to retrofit existing streets with structural elements such as speed humps, traffic tables, and traffic circles for reducing the speed of traffic. Funding for this project is from GO borrowing.

The proposed resolution approves plan documents for the 2016 traffic calming and pedestrian improvements. There is sufficient budget authority available for the estimated cost of the project at \$220,000.
