### Fiscal Note

In the 2016 adopted budget Engineering Major Streets has a major project for Pavement Management (MUNIS 10540) which has \$5.96 million budget for the resurfacing of existing streets. The minor project for the work at Cottage Grove Road-Lumberman to Thompson (MUNIS 11099) is established with sufficient budget authority for the work to be completed in the proposed contract for all agencies involved.

The proposed resolution awards the specified contract for a total estimated cost of \$3,370,360. The breakout of the cost amongst agencies is as follows:
