Fiscal Note

In the adopted 2016 capital budget, Engineering Major Streets has budgeted \$3.7 million for the Royster Clark Development Phase 2 project (MUNIS 10546) to construct the street and sidewalk infrastructure required at the development site. Funding for this project is a combination of TID 44 proceeds and State sources.

The proposed resolution approves plan documents for the 2016 traffic calming costs at Dempsey Rd. for the Royster Phase 2 project at a cost of \$32,000.
