Fiscal Note

This proposed resolution is seeking approval to pursue the specified grant funding for the Flood Control project. The total project cost is estimated at \$167,500, with a grant amount \$83,750 and Storm Water Utility cost of \$83,750. Based on the potential approval of this resolution and the possible award of that grant funding, a second resolution would then be created in the future to request an amendment to storm water's capital budget for the appropriation of the utiliy's estimated cost in the grant project.

WHEREAS, the City of Madison will maintain records documenting all expenditures made during the Municipal Flood Control Grant project; and,

WHEREAS, the City of Madison will submit a final report to the Department which describes all Municipal Flood Control Grant project activities, achievements and data collected, and documentation of the project costs.

THEREFORE BE IT RESOLVED, that the City Engineer is hereby authorized to submit a state grant application and appropria matching funds for a Municipal Flood Control Grant project, 3629 Marsh Rd, to acquire the property via purchase, raze the site and maintain the property as floodplain in perpetuity.

BE IT FURTHER RESOLVED that the City of Madison Common Council requests the funds and assistance available from the Wisconsin Department of Natural Resources under the Municipal Flood Control Grant Program and will comply with state rules for the program, and,

BE IT FURTHER RESOLVED that the Common Council declares the City Engineer as the authorized representative to act or behalf of the City of Madison to submit an application to the State of Wisconsin for financial aid for Municipal Flood Control protection purposes, sign documents, and take necessary action to undertake, direct, and complete this approved flood control project.
