### **Fiscal Note**

In the adopted 2016 capital budget the major program for Monona Terrace building improvements authorizes 307,000 for the improvement of various building components at the convention center (MUNIS 10031). The minor project for the fire alarm system upgrade is established with sufficient budget authority for the estimated cost of the project (MUNIS 20178). Funding is provided from Monona Terrace's reserves.

The proposed resolution approves plan documents at an estimated cost of \$330,000.
