### Fiscal Note

In the adopted 2016 capital budget Engineering - Facilities Management has budgeted \$757,000 for the miscellaneous improvements to the city's fire stations in the Fire Stations Improvements program (MUNIS 10560). The minor project for the Fire Station #9 roof replacement is established with sufficient budget authority for the work in the proposed resolution (MUNIS 11366). Funding for this project is provided by GO borrowing.

The proposed resolution authorizes bids to be received for the planned work at an estimated cost of \$168,000.
