In the adopted 2016 capital budget Fleet Services has \$5.4 million appropriated for the Fleet Facility relocation to Nakoosa Trail (MUNIS 10305). The proposed resolution authorizes the bidding for the Cub Foods demolition in accordance with the plans for this project. Funding is provided from GO borrowing.
