### **Fiscal Note**

As stated in the Employment Agreement between the City of Madison and William T. Vandenbrook, the Fleet Service Superintendent and Public Works Leader's initial year's salary will be based on a total annualized rate of \$138,877, effective August 28th, 2016. The Fleet Service 2016 operating budget includes sufficient funding for the costs. Annual salary adjustments may be made during the term of the agreement at the Mayor's discretion, subject to Common Council approval.
