WHEREAS, Midwest Equity Properties, LLC, has satisfactorily completed the installation of sanitary sewer, storm sewer, and street improvements (including bituminous surface pavement) by private contract, in accordance with the City of Madison Standard Specifications for Public Works Construction, at: 4817 and 4902 -4908 Hammersley Road (Pacific Cycle).

That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A" \$5,417.50.

- 4. That the street improvements, **including the bituminous pavement**, on the following streets be and are hereby accepted:
  - · Hammersley Road from Reetz Road to 212 feet east of Reetz Road
  - Hammersley Road from 212 feet east of Reetz Road to W Beltline Frontage Road

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 53B2340 \$14,395.00 for a useful life of 40 years.
