### Fiscal Note

In the adopted 2016 capital budget, Engineering Facilities Management has budgeted \$757,000 for the Fire Building Improvements program (MUNIS 10560). This program funds miscellaneous improvements to the City's Fire Stations. The work for the roof replacement at Fire Station #9 in this proposed resolution is sufficiently budgeted as a minor project within that program (MUNIS 11366). Funding is provided by GO borrowing.

The proposed resolution awards the contract at an estimated cost of \$163,300.
