### Fiscal Note

In the adopted 2016 capital budget Engineering - Major Streets has budgeted \$50,000 in the Bridge Repair program for the repair, replacement, and painting of the City's bridges. The improvements specified in the contract within this resolution provide for repairs budgeted in the minor project for the Williamson Street Bridge (MUNIS 11400). Funding is provided by GO borrowing.

The proposed resolution awards the contract at an estimated cost of \$64,990.
