### Fiscal Note

In the adopted 2016 Capital Budget the Parks Division has budgeted \$250,000 for Esther Beach Improvements (MUNIS 17140-51-200). This project provides funding for improvements to Esther Beach Park in accordance with the adopted Esther Beach Park master plan. This project has a balance of \$236,367.77; the estimated cost is \$200,000. Should the resolution be approved the remaining balance would be \$36,367.77.

BE IT RESOLVED,
