#### **Fiscal Note**

In the adopted 2016 capital budget the Stormwater Utility budgeted \$100,000 for the dredging of retention ponds and other stormwater features within the Dredging Projects program (MUNIS 11315). The minor project for the Monona Bay weed cutter dredging is established with sufficient budget authority for this proposed resolution (MUNIS 11351). Funding is provided by GO borrowing.
