Fiscal Note

The proposed resolution approves plan documents to receive bids for the Madison Water Utility Vehicle Storage Building Improvements component of the Paterson Street Operations Center remodel (MUNIS 10442). The estimated cost of this work is \$3 million. In the 2017 Executive Capital Budget the Water Utility has budgeted \$4.325 million for work associated with the Paterson Street remodel project. Funding is provided by Revenue Bonds.

The proposed resolution approves plan documents at an estimated cost of \$3 million, which is budgeted in the Water Utility's 2017 Executive Capital Budget.
