Fiscal Note

In the adopted 2016 Capital Budget the Parks Division has budgeted \$250,000 for Esther Beach Improvements (MUNIS 17140-51-130). This project provides funding for improvements to Esther Beach Park in accordance with the adopted Esther Beach Park master plan. The adopted 2016 Capital Budget for the Parks Division has budgeted \$1.72M for Playground/Accessibility Improvements (MUNIS 17438-51-130). This program has sufficient funding for the proposed work in this resolution. Funding is provided by GO borrowing.

The proposed resolution awards the contract for the Esther Beach Park Phase II Improvements at an estimated cost of \$261,930.
